Pandemic Lessons 101

As a PACS graduate from the Class of 1985 and an educator in the district for almost 30 years, I thought I had seen it all, but then it happened. Unfortunately, we all know what "it" is, because COVID-19 has impacted all of us profoundly and altered our lives in a variety of ways.

On March 16, 2020, it seemed so surreal that we would be saying goodbye to our students for what we thought was a three-week hiatus. Little did we know that those three weeks would be just a drop in the bucket and that PACS and the world as we knew it would forever be changed.

When we think of COVID-19, the words anxiety, sadness, and uncertainty immediately come to mind. Over the course of the pandemic, several local families lost loved ones to COVID-19, and numerous others were negatively impacted physically, emotionally, and/or financially. At PACS, we tried to do our best to reach students and families by providing quality instruction, counseling, meals, transportation, and whatever support could be offered, both in person and from afar. While we don't know at this point the lasting impact that a global pandemic will have on our children, my hope is that when our kids look back on the years of 2020 and 2021, that they remember not only the tragedies that occurred, but the triumphs as well.

For instance, I will remember our healthcare workers, the real heroes of 2020-2021. I had the absolute honor of interviewing several PACS alums who are healthcare workers for a series that we created called "Leaders of the PACS." The pure dignity and bravery displayed by each and every one of these graduates was awe inspiring to say the least. In addition, I will remember our local healthcare heroes testing, treating, vaccinating, and supporting a school and a community in need. We can only hope that these individuals realize that we are forever in their debt, and how grateful we are to them for going above and beyond to provide comfort and hope during some of our darkest days.

I will remember how our administrators, faculty, staff, school board members, parents, community members, and students worked together to balance safety concerns, academic ramifications, and emotional considerations to make the most of the 2019-2020 and 2020-2021 school years. There were absolutely highs and lows, agreements and disagreements, and good times and bad, but through it all, everyone kept the mantra of doing what is best for kids close to their hearts. Ultimately, we are all in this together, and will undoubtedly come out stronger and better on the other side when all is said and done.

I will remember how individuals and groups of people stepped up to create change and put smiles on so many faces sorely in need. Many examples come to mind, but there are a few that exemplify the many. There was the Lobdell Family from HealthWay Family of Brands, who donated \$250 to each member of the Class of 2020 to show support and provide a boost to young adults who were entering a world filled with uncertainty. There were members of student organizations and individuals from the senior class who organized community service projects based on the desire to help others and make a difference. There were also students, advisers, and coaches who found ways to bring small pieces of normality and hope back to our school and community by creating virtual charity events, performing in top-notch theatrical productions, and bringing the thrill of competition back to the courts and fields of PACS.

If you ask me what I will remember the most about the past couple of years, the answer is easy. I will absolutely remember the resiliency, flexibility, kindness, compassion, and genuine magnificence of the children in our PACS community. As an educator, I am so blessed because my students teach me lessons and find ways to utterly amaze me each and every day. I remember being anxious prior to the first day of in-person instruction this year, and Superintendent Tom Jennings wisely gave me some advice. He said, "Once you see the kids, everything will be fine." Truer words were never spoken. My hope is that if we've learned anything from this experience as a school district, a community, and a society, it's that we should always remember to use the hearts of our children as our guiding lights, as there is nothing that we won't be able to overcome, including a global pandemic, if we do.

The Return of Athletics

The return of athletics during the 2020-2021 school year has been a welcomed challenge. A challenge in the sense that there have been many obstacles to overcome daily to guarantee that safety measures are met while also providing as close to a normal experience for the student-athletes. The logistics surrounding participation in sports have been altered drastically. Mask wearing is mandatory, regular sanitation of equipment throughout practices and contests takes place, and coaches have been tasked to alter practices to keep contact limited and group sizes reduced to limit exposure. Athletic schedules were created to keep students within their region, bringing back the old Oswego County league for Fall and Winter sports. Outdoor sports have been allowed a limited number of spectators while many Indoor sports were not allowed spectators at all, changing the dynamic of the game atmosphere from what we have grown accustomed to.

All this has been welcomed though because of the clear importance the experiences play in our student athletes' life. Since athletics were approved by New York State and Section 3 for the 2020-2021 school year, the energy in the building changed drastically. Attendance increased, students changing from remote learning to in-person learning increased, and with all of that, providing a sense of normalcy for the students has continued to increase. We have adjusted and accepted the protocols that have been thrown our way because we understand the importance these experiences play in the students' lives. While all of this has been different and at times stressful on the coaches and athletes, everyone has done a tremendous job following procedure and performing at a high level.

The Pulaski Historical Society at 3428 Maple Ave. in Pulaski is the custodian of many alumni archives, along with being a repository for local history of all types. Located in the former Ben Snow home on maple Avenue in Pulaski, the Society has a carriage house annex from which many programs our conducted.

The Society conducts tours by appointment, and can be reached by email at: PHS conducts interesting monthly program meetings and produces a monthly newsletter and Facebook page. Weekly teasers on the Facebook are quite popular!

Half-Shire Historical Society, located in the former Richland School, represents the surrounding eleven towns of northern Oswego County, the Lewis County towns of Montague and Osceola, the Oneida County towns of Florence and Camden. The Society concentrates greatly on genealogical research and assists with Ancestry DNA test interpretations. Half-Shire produces a 12-page quarterly newsletter, a 16-page quarterly Literary Review, and conducts monthly lunch program meetings in Richland, and annual spring and fall dinner dances that are open to the public. A new addition to the facility is a classroom dedicated to the history of our schools in Pulaski and surrounding districts. Some highlights:


- Our safety protocols have been effective and PACS remained open for students.
- Our elementary students received in-person instruction five days per week for the entire school year.
- Our secondary students received more in-person instruction throughout the year than any school in the region.
- When students were required to work remotely, 100% had access to chrome books and the internet so they could continue learning.
- Our students were able to participate in athletics, clubs, music, physical education, art, and drama.
- Our staff received COVID vaccinations as soon as they were eligible.
- Sound, long-range financial planning has helped us maintain and improve programming while keeping taxes flat for the 21-22 school year.

Despite the many challenges we continue to face, I am optimistic about where we are and where we were headed.
