A Message From the Pulaski Board of Education

We would like to express our heartfelt gratitude to our PACS staff and the entire school community for their unwavering commitment and dedication to our students and our school.

During the 2024-25 budget development process, the PACS Board of Education was committed to crafting a spending plan centered on enhancing academic opportunities, maintaining rigor, ensuring sustainability, and optimizing school operations. The outcome is a budget that advances high-quality programming for our students while being responsive to economic factors affecting both the District and the community.

The proposed 2024-25 school budget totals \$31,258,000, which is a 2.5% increase over last year. If approved by voters, this budget would result in a tax levy increase of 1.8% or \$132,357, which is below the District's calculated tax levy limit this year.

A public hearing to present the 2024-25 budget will be held at 6:30 p.m. Tuesday, May 14, in the Pulaski Middle-High School Library. Voting will take place Tuesday, May 21, from 8 a.m. to 8 p.m. at the Ringgold Fire Hall. The vote will include the 2024-25 budget, a proposition to withdraw \$100,000 from the bus purchase reserve, the election of three members to the PACS Board of Education, and a proposition to create a capital reserve in the amount of \$2,000,000 to offset costs for future renovations and improvements to District facilities. The District is currently designing a capital project to propose to voters next fall.

The budget also includes \$100,000 to be used toward a capital outlay project. The New York State Education Department allows for schools to complete capital improvement projects of up to \$100,000 during the proposed budget year. Building aid revenue is then received the following year (PACS state aid rate is 94%). The 2024-25 capital outlay project will renovate the technology classroom and shop at Pulaski Middle-High School.

The Pulaski Academy & Central School District has a tradition of sound financial planning and budget development. The Board of Education and administrative team will continue to be strategic with our resources to provide opportunities and programs for students that we can all be proud of.

- ✓ A citizen of the United States
- A resident of the district for at least 30 days

You do NOT have to be registered to vote.

You do NOT have to own property in the district, but you MUST reside in the district.

Identification and proof of residence WILL be requested at the time of voting.

2024-2025 Budget

Shall the Board of Education of the Pulaski Central School District No. 1 of the Towns of Richland, Albion and Sandy Creek, Oswego County, New York be authorized to expend a sum not exceeding \$31,258,000 commencing July 1, 2024 and ending on June 30, 2025, and to levy the necessary tax on the taxable property of said District?

2024 Capital Project Reserve Fund

Shall the Board of Education of the Pulaski Central School District No. 1 of the Towns of Richland, Albion and Sandy Creek, Oswego County, New York (the "District") be authorized to establish a capital reserve fund pursuant to Section 3651 of the New York Education Law, to be known as the "2024 Capital Project Reserve Fund," to be used for renovations and improvements to District facilities, in an ultimate amount of \$2,000,000 (plus interest earned thereon), having a probable term of five (5) years and be authorized to raise \$2,000,000 to fund such capital reserve fund in the current or future years through various sources including, but not limited to, state aid reimbursement, cost saving measures resulting in unexpended funds or unappropriated fund balance and other legally available funds of the District?

2024-2025 Bus Reserve Withdrawal

Shall the Board of Education of the Pulaski Central School District No. 1 of the Towns of Richland, Albion and Sandy Creek, Oswego County, New York be authorized to expend a sum not exceeding \$100,000 or so much thereof as may be necessary from the 2022 Bus Purchase Reserve Fund for the purchase of transportation vehicles?
